

Information clause on the processing of personal data of the employees or associates of the Bidder/Contractor

The fulfillment of the information obligation in connection with the requirements of Article 13 of Regulation 2016/679 of the European Parliament and the Council of the European Union of 27th April 2016 on the protection of individuals with regard to the processing of personal data and on the free exchange of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter: GDPR), we inform as follows:

3. Your personal data that was transferred to Chemar Rurociągi Sp. z o.o. by* - whom you represent/are an employee/associate constitute, depending on the type of cooperation, contact information, data contained in your documents confirming qualifications or experience.
4. Your personal data may be processed by Chemar Rurociągi Sp. z o.o. depending on the type of cooperation, for the following purposes:
 - performance of obligations under the contract with Chemar Rurociągi Sp. z o.o., the party of which is/will be*, in particular for the purpose of verifying statements made by*, including confirmation of the qualifications of the persons designated for the realization of the contract, contact during the realization of the contract, exchange of correspondence, issue of powers of attorney to represent Chemar Rurociągi Sp. z o.o., control of the proper realization of the contract, settlement of the contract, maintaining the principles of confidentiality and occupational health and safety,
 - service, investigation and defense in the event of claims, including claims between Chemar Rurociągi Sp. z o.o. and you or between Chemar Rurociągi Sp. z o.o. and*,
5. The legal basis of processing of your personal data by Chemar Rurociągi Sp. z o.o. is:
 - fulfillment of legal obligations of Chemar Rurociągi Sp. z o.o. (in accordance with Article 6 (1) (c) of the GDPR) on the basis of legal provisions (depending on the type of cooperation),
 - legally justified interest of Chemar Rurociągi Sp. z o.o. (in accordance with Article 6 (1) (f) of the GDPR).
6. Your personal data may be transferred to other cooperating entities, in particular providing services: legal, IT, correspondence and parcels delivery and entities authorized to receive this data on the basis of applicable law, e.g. courts and state authorities.

7. We store your personal data for the period:
- reserved by law,
 - until the expiration of mutual claims under this agreement,
 - until the expiration of time limits for claims for tax liabilities related to the above-mentioned agreement
8. With regard to the processing of your personal data, you have the right to request the administrator to access them, correct or limit them or object to their processing. Your rights may be limited in accordance with the provisions of the GDPR. Your rights will be realized by the administrator upon request
9. If, in your opinion, the processing of your data violates the provisions on the protection of personal data, you have the right to lodge a complaint against their processing to the President of the Personal Data Protection Office with its seat in Warsaw at ul. Stawki 2.
10. Your personal data will not be processed in an automated manner. Your data will not be profiled.
